


## Senior LinkAge Line

## Overview

The Senior LinkAge Line is a free, statewide service of the Minnesota Board on Aging in partnership with Minnesota's area agencies on aging. The Senior LinkAge Line helps older Minnesotans and caregivers find answers and connect to the services and support they need.



## Senior LinkAge Line Services

### Information and assistance

• Understand and connect with resources such as Medicare, housing, transportation, food, chore services, financial assistance, reporting fraud, affordable prescriptions, etc.

### Resource coordination

Assess, provide support planning and longer-term follow-up for people who need more
assistance to stay in their home or return home from a nursing facility or hospital stay

### Communications and education

Educate older adults, caregivers and providers on how to navigate aging resources

### Preadmission screening

 Fulfill federal nursing facility requirement to help people live in the most integrated setting possible




