1.3 "Section 1. [260.61] CITATION.

1.4 Sections 260.61 to 260.695 may be cited as the "Minnesota African American Family
1.5 Preservation and Child Welfare Disproportionality Act."

1.6 Sec. 2. [260.62] PURPOSES.

1.7 (a) The purposes of the Minnesota African American Family Preservation and Child
1.8 Welfare Disproportionality Act are to:

1.9 (1) protect the best interests of African American and disproportionately represented
1.10 children;

1.11 (2) promote the stability and security of African American and disproportionately
1.12 represented children and families by establishing minimum standards to prevent arbitrary
1.13 and unnecessary removal of African American and disproportionately represented children
1.14 from their families; and

1.15 (3) improve permanency outcomes, including family reunification, for African American
1.16 and disproportionately represented children.

1.17 (b) Nothing in this legislation is intended to interfere with the protections of the Indian
1.18 Child Welfare Act of 1978, United States Code, title 25, sections 1901 to 1963.

1.19 Sec. 3. [260.63] DEFINITIONS.

1.20 Subdivision 1. Scope. The definitions in this section apply to sections 260.61 to 260.695.

2.1 Subd. 2. **Active efforts.** "Active efforts" means a rigorous and concerted level of effort
2.2 that the responsible social services agency must continuously make throughout the time
2.3 that the responsible social services agency is involved with an African American or
2.4 disproportionately represented child and the child's family. To provide active efforts to
2.5 preserve an African American or disproportionately represented child's family, the responsible
2.6 social services agency must continuously involve an African American or disproportionately
2.7 represented child's family and the African American Child Welfare Oversight Council in
2.8 all services for the family, including case planning and choosing services and providers,
2.9 and inform the family of the ability to request a case review by the commissioner under
2.10 section 260.694. When providing active efforts, a responsible social services agency must
2.11 consider an African American or disproportionately represented family's social and cultural
2.12 values at all times while providing services to an African American or disproportionately
2.13 represented child and family. Active efforts includes continuous efforts to preserve an
2.14 African American or disproportionately represented child's family and to prevent the
2.15 out-of-home placement of an African American or disproportionately represented child. If
2.16 an African American or disproportionately represented child enters out-of-home placement,
2.17 the responsible social services agency must make active efforts to reunify the African
2.18 American or disproportionately represented child with the child's family as soon as possible.
2.19 Active efforts sets a higher standard for the responsible social services agency than reasonable
2.20 efforts to preserve the child's family, prevent the child's out-of-home placement, and reunify
2.21 the child with the child's family. Active efforts includes the provision of reasonable efforts
2.22 as required by Title IV-E of the Social Security Act, United States Code, title 42, sections
2.23 670 to 679c.

2.24 Subd. 3. **Adoptive placement.** "Adoptive placement" means the permanent placement
2.25 of an African American or disproportionately represented child made by the responsible
2.26 social services agency upon a fully executed adoption placement agreement, including the
2.27 signatures of the adopting parent, the responsible social services agency, and the
2.28 commissioner of human services according to section 260C.613, subdivision 1.

2.29 Subd. 4. **African American child.** "African American child" means a child having
2.30 origins in Africa, including a child of two or more races who has at least one parent with
2.31 origins in Africa.

2.32 Subd. 5. **Best interests of the African American or disproportionately represented**
2.33 **child.** The "best interests of the African American or disproportionately represented child"
2.34 means providing a culturally informed practice lens that acknowledges, utilizes, and embraces
2.35 the African American or disproportionately represented child's community and cultural

3.1 norms and allows the child to remain safely at home with the child's family. The best interests
3.2 of the African American or disproportionately represented child support the child's sense
3.3 of belonging to the child's family, extended family, kin, and cultural community.

3.4 Subd. 6. **Child placement proceeding.** (a) "Child placement proceeding" means any
3.5 judicial proceeding that could result in:

3.6 (1) an adoptive placement;

3.7 (2) a foster care placement;

3.8 (3) a preadoptive placement; or

3.9 (4) a termination of parental rights.

3.10 (b) Judicial proceedings under this subdivision include a child's placement based upon
3.11 a child's juvenile status offense, but do not include a child's placement based upon:

3.12 (1) an act which if committed by an adult would be deemed a crime; or

3.13 (2) an award of child custody in a divorce proceeding to one of the child's parents.

3.14 Subd. 7. **Commissioner.** "Commissioner" means the commissioner of human services
3.15 or the commissioner's designee.

3.16 Subd. 8. **Custodian.** "Custodian" means any person who is under a legal obligation to
3.17 provide care and support for an African American or disproportionately represented child,
3.18 or who is in fact providing daily care and support for an African American or
3.19 disproportionately represented child. This subdivision does not impose a legal obligation
3.20 upon a person who is not otherwise legally obligated to provide a child with necessary food,
3.21 clothing, shelter, education, or medical care.

3.22 Subd. 9. **Disproportionality.** "Disproportionality" means the overrepresentation of
3.23 African American children and other disproportionately represented children in the state's
3.24 child welfare system population as compared to the representation of those children in the
3.25 state's total child population.

3.26 Subd. 10. **Disproportionately represented child.** "Disproportionately represented child"
3.27 means a child whose race, culture, ethnicity, or low-income socioeconomic status is
3.28 disproportionately encountered, engaged, or identified in the child welfare system as
3.29 compared to the representation in the state's total child population.

3.30 Subd. 11. **Egregious harm.** "Egregious harm" has the meaning given in section 260E.03,
3.31 subdivision 5.

4.1 Subd. 12. **Foster care placement.** "Foster care placement" means the court-ordered
4.2 removal of an African American or disproportionately represented child from the child's
4.3 home with the child's parent or legal custodian and the temporary placement of the child in
4.4 a foster home, in shelter care or a facility, or in the home of a guardian, when the parent or
4.5 legal custodian cannot have the child returned upon demand, but the parent's parental rights
4.6 have not been terminated. A foster care placement includes an order placing the child under
4.7 the guardianship of the commissioner, pursuant to section 260C.325, prior to an adoption
4.8 being finalized.

4.9 Subd. 13. **Imminent physical damage or harm.** "Imminent physical damage or harm"
4.10 means that a child is threatened with immediate and present conditions that are
4.11 life-threatening or likely to result in abandonment, sexual abuse, or serious physical injury.

4.12 Subd. 14. **Responsible social services agency.** "Responsible social services agency"
4.13 has the meaning given in section 260C.007, subdivision 27a.

4.14 Subd. 15. **Parent.** "Parent" means the biological parent of an African American or
4.15 disproportionately represented child or any person who has legally adopted an African
4.16 American or disproportionately represented child who, prior to the adoption, was considered
4.17 a relative to the child, as defined in subdivision 16. Parent includes an unmarried father
4.18 whose paternity has been acknowledged or established and a putative father. Paternity has
4.19 been acknowledged when an unmarried father takes any action to hold himself out as the
4.20 biological father of a child.

4.21 Subd. 16. **Preadoptive placement.** "Preadoptive placement" means a responsible social
4.22 services agency's placement of an African American or disproportionately represented child
4.23 with the child's family or kin when the child is under the guardianship of the commissioner,
4.24 for the purpose of adoption, but an adoptive placement agreement for the child has not been
4.25 fully executed.

4.26 Subd. 17. **Relative.** "Relative" means:

4.27 (1) an individual related to the child by blood, marriage, or adoption;

4.28 (2) a legal parent, guardian, or custodian of the child's sibling;

4.29 (3) an individual who is an important friend of the child or child's family with whom
4.30 the child has resided or has had significant contact; or

4.31 (4) an individual who the child or the child's family identify as related to the child's
4.32 family.

5.1 Subd. 18. **Safety network.** "Safety network" means a group of individuals identified by
5.2 the parent and child, when appropriate, that is accountable for developing, implementing,
5.3 sustaining, supporting, or improving a safety plan to protect the safety and well-being of a
5.4 child.

5.5 Subd. 19. **Sexual abuse.** "Sexual abuse" has the meaning given in section 260E.03,
5.6 subdivision 20.

5.7 Subd. 20. **Termination of parental rights.** "Termination of parental rights" means an
5.8 action resulting in the termination of the parent-child relationship under section 260C.301.

5.9 Sec. 4. **[260.64] DUTY TO PREVENT OUT-OF-HOME PLACEMENT AND**
5.10 **PROMOTE FAMILY REUNIFICATION.**

5.11 (a) A responsible social services agency shall make active efforts to prevent the
5.12 out-of-home placement of an African American or disproportionately represented child,
5.13 eliminate the need for a child's removal from the child's home, and reunify an African
5.14 American or disproportionately represented child with the child's family as soon as
5.15 practicable.

5.16 (b) Prior to petitioning the court to remove an African American or disproportionately
5.17 represented child from the child's home, a responsible social services agency must work
5.18 with the child's family to allow the child to remain in the child's home while implementing
5.19 a safety plan based on the family's needs. The responsible social services agency must:

5.20 (1) make active efforts to engage the child's parent or custodian and the child, when
5.21 appropriate;

5.22 (2) assess the family's cultural and economic needs;

5.23 (3) hold a family group consultation meeting and connect the family with supports, to
5.24 establish a safety network for the family; and

5.25 (4) provide support, guidance, and input to assist the family and the family's safety
5.26 network with developing the safety plan.

5.27 (c) The safety plan must:

5.28 (1) address the specific allegations impacting the child's safety in the home. If neglect
5.29 is alleged, the safety plan must incorporate economic services and supports to address the
5.30 family's specific needs and prevent neglect;

5.31 (2) incorporate family and community support to ensure the child's safety while keeping
5.32 the family intact; and

6.1 (3) be adjusted as needed to address the child's and family's ongoing needs and support.

6.2 The responsible social services agency is not required to establish a safety plan in a case
6.3 with allegations of sexual abuse or egregious harm.

6.4 (d) Unless the court finds by clear and convincing evidence that the child would be at
6.5 risk of serious emotional damage or serious physical damage if the child were to remain in
6.6 the child's home, a court shall not order a foster care or permanent out-of-home placement
6.7 of an African American or disproportionately represented child alleged to be in need of
6.8 protection or services. At each hearing regarding an African American or disproportionately
6.9 represented child who is alleged or adjudicated to be in need of child protective services,
6.10 the court shall review whether the responsible social services agency has provided active
6.11 efforts to the child and the child's family and shall require the responsible social services
6.12 agency to provide evidence and documentation that demonstrates that the agency is providing
6.13 culturally informed, strength-based, community-involved, and community-based services
6.14 to the child and the child's family.

6.15 (e) When determining whether the responsible social services agency has made active
6.16 efforts to preserve the child's family, the court shall make findings regarding whether the
6.17 responsible social services agency made appropriate and meaningful services available to
6.18 the child's family based upon the family's specific needs. If a court determines that the
6.19 responsible social services agency did not make active efforts to preserve the family as
6.20 required by this section, the court shall order the responsible social services agency to
6.21 immediately provide active efforts to the child and child's family to preserve the family.

6.22 **Sec. 5. [260.65] NONCUSTODIAL PARENTS; TEMPORARY OUT-OF-HOME**
6.23 **PLACEMENT.**

6.24 (a) Prior to or within 48 hours of the removal of an African American or
6.25 disproportionately represented child from the child's home, the responsible social services
6.26 agency must make active efforts to identify and locate the child's noncustodial or
6.27 nonadjudicated parent and the child's relatives to notify the child's parent and relatives that
6.28 the child is, or will be, placed in foster care, and provide the child's parent and relatives
6.29 with a list of legal resources. The notice to the child's noncustodial or nonadjudicated parent
6.30 and relatives must also include the information required under section 260C.221, paragraph
6.31 (b). The responsible social services agency must maintain detailed records of the agency's
6.32 efforts to notify parents and relatives under this section.

6.33 (b) Notwithstanding the provisions of section 260C.219, the responsible social services
6.34 agency must assess an African American or disproportionately represented child's

7.1 noncustodial or nonadjudicated parent's ability to care for the child before placing the child
7.2 in foster care. If a child's noncustodial or nonadjudicated parent is willing and able to provide
7.3 daily care for the African American or disproportionately represented child temporarily or
7.4 permanently, the court shall order that the child be placed in the home of the noncustodial
7.5 or nonadjudicated parent pursuant to section 260C.178 or 260C.201, subdivision 1. The
7.6 responsible social services agency must make active efforts to assist a noncustodial or
7.7 nonadjudicated parent with remedying any issues that may prevent the child from being
7.8 placed with the noncustodial or nonadjudicated parent.

7.9 (c) If an African American or disproportionately represented child's noncustodial or
7.10 nonadjudicated parent is unwilling or unable to provide daily care for the child and the court
7.11 has determined that the child's continued placement in the home of the child's noncustodial
7.12 or nonadjudicated parent would endanger the child's health, safety, or welfare, the child's
7.13 parent, custodian, or the child, when appropriate, has the right to select one or more relatives
7.14 who may be willing and able to temporary care for the child. The responsible social services
7.15 agency must place the child with a selected relative after assessing the relative's willingness
7.16 and ability to provide daily care for the child. If selected relatives are not available or there
7.17 is a documented safety concern with the relative placement, the responsible social services
7.18 agency shall consider additional relatives for the child's placement.

7.19 (d) The responsible social services agency must inform selected relatives and the child's
7.20 parent or custodian of the difference between informal kinship care arrangements and
7.21 court-ordered foster care. If a selected relative and the child's parent or custodian request
7.22 an informal kinship care arrangement for a child's placement instead of court-ordered foster
7.23 care and such an arrangement will maintain the child's safety and well-being, the responsible
7.24 social services agency shall comply with the request and inform the court of the plan for
7.25 the child. The court shall honor the request to forego a court-ordered foster care placement
7.26 of the child in favor of an informal kinship care arrangement, unless the court determines
7.27 that the request is not in the best interests of the African American or disproportionately
7.28 represented child.

7.29 (e) The responsible social services agency must make active efforts to support relatives
7.30 with whom a child is placed in completing the child foster care licensure process and
7.31 addressing barriers, disqualifications, or other issues affecting the relatives' licensure,
7.32 including but not limited to assisting relatives with requesting reconsideration of a
7.33 disqualification under section 245C.21.

7.34 (f) The decision by a relative not be considered as an African American or
7.35 disproportionately represented child's foster care or temporary placement option shall not

8.1 be a basis for the responsible social services agency or the court to rule out the relative for
8.2 placement in the future or for denying the relative's request to be considered or selected as
8.3 a foster care or permanent placement of the child.

8.4 Sec. 6. [260.66] EMERGENCY REMOVAL.

8.5 Subdivision 1. **Emergency removal or placement permitted.** Nothing in this section
8.6 shall be construed to prevent the emergency removal of an African American or
8.7 disproportionately represented child's parent or custodian, or the emergency placement of
8.8 the child in a foster setting, in order to prevent imminent physical damage or harm to the
8.9 child.

8.10 Subd. 2. **Petition for emergency removal; placement requirements.** A petition for a
8.11 court order authorizing the emergency removal or continued emergency placement of an
8.12 African American or disproportionately represented child or the petition's accompanying
8.13 documents, must contain a statement of the risk of imminent physical damage or harm to
8.14 the African American or disproportionately represented child and any evidence that the
8.15 emergency removal or placement continues to be necessary to prevent imminent physical
8.16 damage or harm to the child. The petition or its accompanying documents must also contain
8.17 the following information:

8.18 (1) the name, age, and last known address of the child;

8.19 (2) the name and address of the child's parents and custodians, or, if unknown, a detailed
8.20 explanation of efforts made to locate and contact them;

8.21 (3) the steps taken to provide notice to the child's parents and custodians about the
8.22 emergency proceeding;

8.23 (4) a specific and detailed account of the circumstances that led the agency responsible
8.24 for the emergency removal of the child to take that action; and

8.25 (5) a statement of the efforts that have been taken to assist the child's parents or custodians
8.26 so that the child may safely be returned to their custody.

8.27 Subd. 3. **Emergency proceeding requirements.** (a) The court shall hold a hearing no
8.28 later than 72 hours, excluding weekends and holidays, after the emergency removal of the
8.29 African American or disproportionately represented child. The court shall determine whether
8.30 the emergency removal continues to be necessary to prevent imminent physical damage or
8.31 harm to the child.

9.1 (b) The court shall hold additional hearings whenever new information indicates that
9.2 the emergency situation has ended and at any court hearing during the emergency proceeding
9.3 to determine whether the emergency removal or placement is no longer necessary to prevent
9.4 imminent physical damage or harm to the child.

9.5 (c) Notwithstanding section 260C.163, subdivision 3, and the provisions of Minnesota
9.6 Rules of Juvenile Protection Procedure, rule 25, a parent or custodian of an African American
9.7 or disproportionately represented child who is subject to an emergency hearing under this
9.8 section and Minnesota Rules of Juvenile Protection Procedure, rule 30, must be represented
9.9 by counsel. The court must appoint qualified counsel to represent a parent if the parent
9.10 meets the eligibility requirements in section 611.17.

9.11 Subd. 4. **Termination of emergency removal or placement.** (a) An emergency removal
9.12 or placement of an African American or disproportionately represented child must
9.13 immediately terminate once the responsible social services agency or court possesses
9.14 sufficient evidence to determine that the emergency removal or placement is no longer
9.15 necessary to prevent imminent physical damage or harm to the child, and the child shall be
9.16 immediately returned to the custody of the child's parent or custodian. The responsible social
9.17 services agency or court shall ensure that the emergency removal or placement terminates
9.18 immediately when removal or placement is no longer necessary to prevent imminent physical
9.19 damage or harm to the African American or disproportionately represented child.

9.20 (b) An emergency removal or placement ends when the court orders, after service upon
9.21 the African American or disproportionately represented child's parents or custodian, that
9.22 the child shall be placed in foster care upon a determination supported by clear and
9.23 convincing evidence that custody of the child by the child's parent or custodian is likely to
9.24 result in serious emotional or physical damage to the child.

9.25 (c) In no instance shall emergency removal or emergency placement of an African
9.26 American or disproportionately represented child extend beyond 30 days unless the court
9.27 finds by a showing of clear and convincing evidence that:

9.28 (1) continued emergency removal or placement is necessary to prevent imminent physical
9.29 damage or harm to the child; and

9.30 (2) it has not been possible to initiate a child placement proceeding with all of the
9.31 protections under sections 260.61 to 260.68.

10.1 Sec. 7. [260.67] TRANSFER OF PERMANENT LEGAL AND PHYSICAL
10.2 CUSTODY; TERMINATION OF PARENTAL RIGHTS; CHILD PLACEMENT
10.3 PROCEEDINGS.

10.4 Subdivision 1. Preference for transfer of permanent legal and physical custody. If
10.5 an African American or disproportionately represented child cannot be returned to the child's
10.6 parent, the court shall, if possible, transfer permanent legal and physical custody of the child
10.7 to:

10.8 (1) a noncustodial parent under section 260C.515, subdivision 4, if the child cannot
10.9 return to the care of the parent or custodian from whom the child was removed or who had
10.10 legal custody at the time that the child was placed in foster care; or

10.11 (2) a willing and able relative, according to the requirements of section 260C.515,
10.12 subdivision 4, if the court determines that reunification with the child's family is not an
10.13 appropriate permanency option for the child. Prior to the court ordering a transfer of
10.14 permanent legal and physical custody to a relative who is not a parent, the responsible social
10.15 services agency must inform the relative of Northstar kinship assistance benefits and
10.16 eligibility requirements, and of the relative's ability to apply for benefits on behalf of the
10.17 child under chapter 256N.

10.18 Subd. 2. Termination of parental rights restrictions. (a) A court shall not terminate
10.19 the parental rights of a parent of an African American or disproportionately represented
10.20 child based solely on the parent's failure to complete case plan requirements.

10.21 (b) A court shall not terminate the parental rights of a parent of an African American or
10.22 disproportionately represented child in a child placement proceeding unless the allegations
10.23 against the parent involve sexual abuse; egregious harm as defined in section 260C.007,
10.24 subdivision 14; murder in the first, second, or third degree under section 609.185, 609.19,
10.25 or 609.195; murder of an unborn child in the first, second, or third degree under section
10.26 609.2661, 609.2662, or 609.2663; manslaughter of an unborn child in the first or second
10.27 degree under section 609.2664 or 609.2665; domestic assault by strangulation under section
10.28 609.2247; felony domestic assault under section 609.2242 or 609.2243; kidnapping under
10.29 section 609.25; solicitation, inducement, and promotion of prostitution under section 609.322,
10.30 subdivision 1, and subdivision 1a if one or more aggravating factors are present; criminal
10.31 sexual conduct under sections 609.342 to 609.3451; engaging in, hiring, or agreeing to hire
10.32 a minor to engage in prostitution under section 609.324, subdivision 1; solicitation of children
10.33 to engage in sexual conduct under section 609.352; possession of pornographic work
10.34 involving minors under section 617.247; malicious punishment or neglect or endangerment

11.1 of a child under section 609.377 or 609.378; use of a minor in sexual performance under
11.2 section 617.246; or failing to protect a child from an overt act or condition that constitutes
11.3 egregious harm.

11.4 (c) Nothing in this subdivision precludes the court from terminating the parental rights
11.5 of a parent of an African American or disproportionately represented child who for good
11.6 cause desires to voluntarily terminate parental rights of the parent's child under section
11.7 260C.301, subdivision 1, paragraph (a).

11.8 Subd. 3. **Appeals.** Notwithstanding the Minnesota Rules of Juvenile Protection Procedure,
11.9 rule 47.02, subdivision 2, a parent of an African American or disproportionately represented
11.10 child whose parental rights have been terminated may appeal the decision within 90 days
11.11 of the service of notice by the court administrator of the filing of the court's order.

11.12 Sec. 8. **[260.68] RESPONSIBLE SOCIAL SERVICES AGENCY CONDUCT AND**
11.13 **CASE REVIEW.**

11.14 Subdivision 1. **Responsible social services agency conduct.** (a) A responsible social
11.15 services agency employee who has duties related to child protection shall not knowingly:

11.16 (1) make untrue statements about any case involving a child alleged to be in need of
11.17 protection or services;

11.18 (2) intentionally withhold any information that may be material to a case involving a
11.19 child alleged to be in need of protection or services; or

11.20 (3) fabricate or falsify any documentation or evidence relating to a case involving a child
11.21 alleged to be in need of protection or services.

11.22 (b) Any of the actions listed in paragraph (a) shall constitute grounds for adverse
11.23 employment action.

11.24 Subd. 2. **Commissioner notification.** (a) When a responsible social services agency
11.25 makes a maltreatment determination involving an African American or disproportionately
11.26 represented child or places an African American or disproportionately represented child in
11.27 a foster care placement, the agency shall, within seven days of making a maltreatment
11.28 determination or initiating the child's foster care placement, notify the commissioner of the
11.29 maltreatment determination or foster care placement and of the steps that the agency has
11.30 taken to investigate and remedy the conditions that led to the maltreatment determination
11.31 or foster care placement. Upon receiving this notice, the commissioner shall review the
11.32 responsible social services agency's handling of the child's case to ensure that the case plan
11.33 and services address the unique needs of the child and the child's family and that the agency

12.1 is making active efforts to reunify and preserve the child's family. At all stages of a case
12.2 involving an African American or disproportionately represented child, the responsible
12.3 social services agency shall, upon request, fully cooperate with the commissioner and the
12.4 African American Child Welfare Oversight Council and, as appropriate and as permitted
12.5 under statute, provide access to all relevant case files.

12.6 (b) In any adoptive or preadoptive placement proceeding involving an African American
12.7 or disproportionately represented child under the guardianship of the commissioner, the
12.8 responsible social services agency shall notify the commissioner of the pending proceeding
12.9 and of the right of intervention. The notice must include the identity of the child and the
12.10 child's parents whose parental rights were terminated or who consented to the child's
12.11 adoption. Upon receipt of the notice, the commissioner shall review the case to ensure that
12.12 the requirements of this act have been met. When the responsible social services agency
12.13 has identified a nonrelative as an African American or disproportionately represented child's
12.14 adoptive placement, no preadoptive or adoptive placement proceeding may be held until at
12.15 least 30 days after the commissioner receives the required notice or until an adoption home
12.16 study can be completed for a relative adoption, whichever occurs first. If the commissioner
12.17 requests additional time to prepare for the proceeding, the district court must grant the
12.18 commissioner up to 30 additional days to prepare for the proceeding. In cases in which a
12.19 responsible social services agency or party to a preadoptive or adoptive placement knows
12.20 or has reason to believe that a child is or may be African American or a disproportionately
12.21 represented child, proof of service upon the commissioner must be filed with the adoption
12.22 petition.

12.23 Subd. 3. **Case review.** (a) Each responsible social services agency shall conduct a review
12.24 of all child protection cases handled by the agency every 24 months, after establishing a

13.6 (4) the number and race of children whose parents or custodians are referred to
13.7 community-based, culturally appropriate, strength-based, or trauma-informed services;

13.8 (5) the number and race of children removed from their homes;

13.9 (6) the number and race of children reunified with their parents or custodians;

13.10 (7) the number and race of children whose parents or custodians are offered family group
13.11 decision-making services;

13.12 (8) the number and race of children whose parents or custodians are offered the parent
13.13 support outreach program;

13.14 (9) the number and race of children in foster care or out-of-home placement at the time
13.15 that the data is gathered;

13.16 (10) the number and race of children who achieve permanency a through transfer of
13.17 permanent legal and physical custody to a relative, a legal guardianship, or an adoption;

13.19 (11) the number and race of children who are under the guardianship of the commissioner
